<p>Additional resources have been bought and staff trained to allow the school to set up and run 'sensory circuits' on a daily basis. Providing those children, the opportunity to participate in a short sensory motor circuit enables the children to engage effectively with the day ahead.</p> <p>We have continued to book workshops to extend the children's knowledge and understanding of physical education and provide opportunities for all. <i>These workshops are on hold however due to current COVID - 19 restrictions.</i></p> <p>In order to make the most of our outdoor space and outdoor play equipment and encourage involvement and participation of physical activities by the children additional trained and qualified staff have been employed.</p>	<p>Increase participation in after school sports clubs.</p> <p>Re-establish and set up links with sports clubs in the community.</p> <p>When restrictions are lifted, to timetable in Assemblies with a sporting focus.</p> <p>When restrictions are lifted, to have play leaders (year 2) trained and set up to assist the lunchtime play supervisor and further encourage involvement and participation of physical activities during lunchtime.</p>
